**AN ORDINANCE CREATING NEW FUNDS (FUND #2493, FUND #2494, FUND #2495)
FOR THE FY2026 COMPREHENSIVE HIGHWAY INJURY REDUCTION PROGRAM
(CHIRP) GRANT FUNDS**

WHEREAS, as authorized by the Hammond Common Council by Resolution No. 25R-14, the Hammond Police Department applied to the Indiana Criminal Justice Institute (ICJI) for a 2026 Comprehensive Highway Injury Reduction Program (CHIRP) grant for the purpose of reducing injuries and fatalities on roadways; and

WHEREAS, the Hammond Police Department is the recipient of FY2026 CHIRP grant monies in the amount of Fifty-One Thousand Seven Hundred and Fifty Dollars (\$51,750.00) and requires dedicated funds to receipt and disburse this allocation of grant money; and

WHEREAS, the City of Hammond must now have new funds established for receipt and distribution of these funds; and

WHEREAS, the City Controller, requests that new accounts be dedicated and created for the City of Hammond for purposes of accessing funds for the FY2026 CHIRP Grant; and

WHEREAS, the creation of these funds is not an additional appropriation and a public hearing is not required; and

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Hammond that the Hammond City Controller be and is authorized to provide, dedicate, and create new accounts for the City of Hammond in the following FY2026 CHIRP categories:




