AN ORDINANCE VACATING A 446.06 PORTION OF 125TH STREET LYING EAST OF THE EAST RIGHT-OF-WAY LINE OF GASPAR AVENUE AND WEST OF THE WEST RIGHT-OF-WAY LINE OF NEW YORK AVENUE IN THE 1400 BLOCK OF NEW YORK AVENUE IN THE CITY OF HAMMOND, LAKE COUNTY, INDIANA.

WHEREAS, Calumet College of St. Joseph is the fee simple owner of the following described real estate, to wit:

WHEREAS, Calumet College of St. Joseph has filed a Petition for Vacation of a portion of 125th Street with the Common Council of the City of Hammond, Lake County, Indiana, requesting a vacation of 446.06 foot portion of 125th Street lying east of the east right-of-way of Gaspar Avenue and west of the west right-of-way line of New York Avenue, as shown on the plat of Gaspar Gardens Addition to the City of Hammond, recorded as document 2016-059894 in Plat Book 109, page 32 in the Office of the Recorder of Lake County, Indiana, containing 0.620 acres, more or less; and

WHEREAS, the Common Council of the City of Hammond, Lake County, Indiana upon investigation and Public Hearing in accordance with applicable law, finds and determines that the proposed vacation will not hinder the growth or orderly development of the City of Hammond, Lake County, Indiana, or the neighborhood in which it is located or to which it is contiguous; and

WHEREAS, the vacation will not make access to the lands of any persons by means of public way difficult to inconvenient; and

WHEREAS, the vacation would not hinder the public's access to a church, school, or other public building or place; and

WHEREAS, the vacation will not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA, THAT it is desired and deemed necessary to vacate a 446.06 foot portion of 125th Street located in the City of Hammond, and more particularly described as follows:

That portion of 125th Street lying east of the east right-of-way line of Gaspar Avenue and west of the west right of way line of New York Avenue, as shown on the plat of Gaspar Gardens Addition to the City of Hammond, recorded as document 2016-059894 in Plat Book 109, page 32 in the Office of the Recorder of Lake County, Indiana, containing 0.620 acres, more or less

BE IT FURTHER ORDAINED that the Ordinance herein shall have full force and effect from and after Public Hearing hereon, passage and approval by the Common Council of the City of Hammond, Lake County, Indiana, signed by the President thereof, and the approval and signing by the Mayor.
