**A RESOLUTION AUTHORIZING THE CITY OF HAMMOND TO AWARD A
GUARANTEED SAVINGS CONTRACT**

WHEREAS, the Indiana General Assembly has passed legislation which encourages political subdivision, such as Hammond, to research conservation measures or enter guaranteed savings contracts for conservation measures; and

WHEREAS, Under Indiana Code 36-1-12.5 et. seq. a guaranteed savings contract is a contract where a governing body evaluates recommended conservation measures and implements at least one recommended conservation measure; and

WHEREAS; such conservation measures include, utility efficiency programs, water use reduction or wastewater usage costs reduction; and

WHEREAS, the Council by resolution previously authorized the City of Hammond, through its Board of Public Works and Safety, to publically request public utilities and qualified providers to propose conservation measures, utility efficiently programs and information on guaranteed savings accounts; and

WHEREAS, the Board of Public Works received a bid and wishes to make an award; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Council authorizes the City of Hammond, through its Board of Public Works and Safety, to award a contract for conservation measures as per the requirements of Indiana Code 36-1-12.5 et. seq.
