**A RESOLUTION AUTHORIZING THE HAMMOND POLICE DEPARTMENT
TO APPLY FOR A 2017 INDIANA CRIMINAL JUSTICE GRANT TO PREVENT
IMPARED DRIVING**

WHEREAS, The Indiana Criminal Justice Institute (ICJI) annually offers traffic safety grant money to local law enforcement agencies; and

WHEREAS; currently a grant is available for the Hammond Police Department, the Summer Impaired Driving Enforcement Program Grant (SIDE-P) in the amount of \$50,400.00, which will be used to fund police overtime May 25, 2017 thru September 30, 2017; and

WHEREAS, this grant does not require matching funds on the part of the municipality and no funds would have to be expended to receive this grant; and

WHEREAS, the City of Hammond must apply for this grant to be awarded these funds and the Hammond Police Department wishes to make this Grant Application which requires the Approval of the Hammond Common Council; and

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond, that the Hammond Police Department be authorized to apply to the ICJI for the 2017 Summer Impaired Driving Enforcement Program to fund Account Number 221.

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
