**RESOLUTION NO. R35**

**A RESOLUTION SUPPORTING THE INCLUSION OF THE HESSVILLE COMMERCE AND COMMUNITY CREATIVE (H3C) INTO THE INDIANA MAIN STREET PROGRAM**

**WHEREAS**, Indiana Code 4-4-16 establishes the “Indiana Main Street” program for the purposes of encouraging the economic development, redevelopment and improvement of downtown areas in Indiana Cities and towns; and

**WHEREAS**, the Hessville Commerce and Community Creative (H3C) is a nonprofit organization created in 2015 which works to revitalize and beautify the Hessville Hammond downtown area; and

**WHEREAS**, the Indiana Main Street Program is granted by statute the authority to expend money to private persons or corporations for activities appropriate to the purposes of redevelopment; and

**WHEREAS**, the Hessville Community Creative wishes to collaborate with Indiana Main Street to develop vacant spaces in the Hessville downtown area; and

**WHEREAS**, the Hammond Common Council and the Mayor of the City of Hammond wish to show their support for this collaboration; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Common Council of the City of Hammond that the Hammond Common Council supports the collaboration of the Hessville Community Creative with the Indiana Main Street Program, for purposes of redeveloping vacant parcels in the downtown Hessville area.
