WHEREAS, the CARES Act made available \$5 billion in Community Development Block Grant Coronavirus (CDBG-CV) funds. Of this amount, the Department of Housing and Urban Development (HUD) immediately allocated \$2 billion on March 27, 2020, the same day President Donald Trump signed into law the first round of Coronavirus Aid, Relief, and Economic Security Act (CARES ACT), based on the fiscal year 2020 CDBG formula; this constituted the first round of CDBG-CV funds; and

WHEREAS, \$1 billion was required by the Act to be allocated to States and insular area within 45 days of enactment of the ACT; and HUD accomplished this on May 11, 2020, and tis constituted a second round of CDBG-CV funds.

WHEREAS; the remaining \$2 billion in CDBG-CV funds was required by the Act to be allocated to states and local governments at the discretion of the Secretary on a rolling basis; HUD accomplished this on September 11, 2020, and this constitutes a third round of CDBG-CV funds; and

WHEREAS, the CARES-ACT made available a third-round allocation of Community Development Block Grant (CDBG) Program for the City of Hammond in amount of \$408,738; and

- The Mayor of the City of Hammond, Indiana is authorized and directed to prepare a
 substantial amendment of its currently adopted FY2019 Annual Action Plan submission to
 HUD for CDBG-CV funds made available to the City through the CARES-ACT.
