A RESOLUTION SUPPORTING EXECUTIVE ORDER 21-45 RESPECTING NEW EMPLOYEE COVID-19 VACCINATION POLICY

WHEREAS, on December 1, 2021, Executive Order 21-31 declaring a public health emergency for the State of Indiana was renewed for the twenty-first time; and

WHEREAS, the Centers for Disease Control and Prevention (CDC) has issued guidance indicating COVID-19 vaccinations, mask wearing, and social distancing are the best ways to protect against COVID-19 illness and recommends COVID-19 vaccination to all eligible individuals; and

WHEREAS, Mayor Thomas M. McDermott, Jr. recently enacted Executive Order 21-45 regarding New Employee COVID-19 Vaccination Policy (hereinafter referred to as "the policy"); and

WHEREAS, the policy provides, in substantive part, that to become a new City of Hammond employee one must be fully vaccinated, report their vaccination status, and provide the Personnel Department with a medical record of one's vaccination status; and

WHEREAS, this Executive Order furthers the city's desire to promote vaccination and to encourage people to limit exposing members of the public to COVID-19 in their interactions as employees of the City of Hammond; and

WHEREAS, it is the City Council's desire to show support for the Mayor's Executive Order 21-45, which is attached hereto as Exhibit "A", and the New Employee Vaccination Policy contained therein;

BE IT THEREFORE RESOLVED, by the Common Council of the City of Hammond,

that it supports Executive Order 21-45 and the New Employee Vaccination Policy contained therein.

BE IT FURTHER RESOLVED by the Common Council of the City of Hammond that this resolution shall be in full force and effect from and after its passage by the Common Council, signing by the President thereof and approval by the Mayor.
