WHEREAS, numerous federal and local community grants are available to provide critical funding necessary to support a range of public safety program areas, including but not limited to, community development, education and training, and equipment improvements; and

WHEREAS, Fiscal Year 2025 and Fiscal Year 2026 grant cycles are now open for the Hammond Fire Department and Hammond Police Department to apply for these public safety grants; and

WHEREAS, these grants do not require matching funds on the part of the municipality and no funds would have to be expended to receive said grants; and

WHEREAS, the City of Hammond must complete an application in order to be awarded each requested grant and the Hammond Fire and Police Departments wish to make these grant applications and require the approval of the Hammond Common Council; and




