RESOLUTION DECLARING JULY OLDER AMERICANS MONTH IN HAMMOND, INDIANA AND TO APPLY TO JOIN AARP NETWORK OF AGE-FRIENDLY COMMUNITIES

WHEREAS: In the United States, the proportion of individuals aged 65 and over is projected to rise by 2030.

WHEREAS: Research shows that older Americans overwhelmingly wish to remain in their homes and communities as they age; and

WHEREAS: There are numerous social and economic benefits to building a community that is inclusive and meets the changing needs of all age levels of our residents; and

WHEREAS: Aging is a lifelong process, such that an age-friendly community is not just "elder-friendly" but also facilitates the well-being of all ages; and

WHEREAS: An age-friendly community has policies, services, and structures that facilitate older adults staying healthy, participating in economic growth, remaining socially active, and living in security. Communities in which older adults can "successfully age" are more likely to both mitigate the challenges and enjoy the opportunities related to their older citizens.

WHEREAS: The City of Hammond is a strong proponent of identifying the needs of its older adult citizens and launching age-friendly initiatives through developing a 5-year Aging Plan; and

RESOLUTION DECLARING JULY OLDER AMERICANS MONTH IN HAMMOND, INDIANA AND TO APPLY TO JOIN AARP NETWORK OF AGE-FRIENDLY COMMUNITIES

WHEREAS: The City of Hammond will develop a 5-year Aging Plan (2025-2029), that is expected to be presented to the Mayor and the Hammond Common Council for review and approval; and

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Hammond as follows:

- 1. We proclaim July 2025 as OLDER AMERICANS MONTH in Hammond, Indiana. We urge all citizens, business leaders, elected officials, government staff, philanthropists, educators, civic groups, advocacy organizations, and service organizations to recognize that older adults are a valuable resource to our community. Additionally, we encourage everyone to engage older adults in all aspects of community and civic life.
- 2. The City of Hammond will initiate action to join the AARP Network of Age-Friendly Communities.
- 3. That the City Council recommends the naming of a City of Hammond Aging-Friendly Committee to:
 - a. Convene a steering team to lead the Age-Friendly Community Initiative. The steering team should actively seek input from diverse stakeholders, with significant participation from older City of Hammond residents, and
 - b. Draft, review, and assist in the implementation of a 2025-2029 City of Hammond Aging Plan and incorporate the AARP Age-Friendly Community framework in the Plan.
