RESOLUTION NO. 816

**A RESOLUTION OF THE CITY OF HAMMOND COMMON COUNCIL
DESIGNATING THE FUNDS INTO WHICH DISTRIBUTIONS OF THE FINANCIAL
INSTITUTIONS TAX (FIT) AND COMMERCIAL VEHICLE EXCISE TAX (CVET)
SHALL BE RECEIPTED FOR THE 2026 SPRING DISTRIBUTION**

WHEREAS, I.C. 6-5.5-8-2(c) and I.C. 6-6-5.5-20(h) provide that distributions of the Financial Institutions Tax (FIT) and Commercial Vehicle Excise Tax (CVET) may be deposited into any fund maintained by a taxing unit and may be used for any purpose allowed by law; and

WHEREAS, such legislative changes provide flexibility to taxing units, including the City of Hammond, in receipting and utilizing FIT and CVET distributions; and

WHEREAS, the Indiana State Board of Accounts has issued guidance stating that if FIT and CVET distributions are receipted into any fund other than the General Fund, the legislative body must formally identify the fund into which such distributions will be receipted; and

WHEREAS, the Common Council of the City of Hammond desires to ensure proper accounting, transparency, and audit compliance in accordance with Indiana law and State Board of Accounts guidance; and

NOW, THEREFORE, BE IT RESOLVED that the Common Council of the City of Hammond hereby designates FIT and CVET funds as follows:

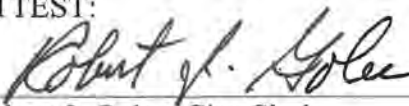

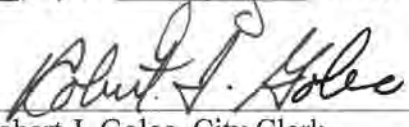

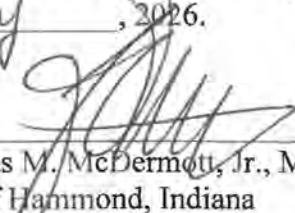
