<u>MINUTES</u> BOARD OF PUBLIC WORKS AND SAFETY JANUARY 10, 2013

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:03 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. O'Connor –present; Mr. Dostatni – present; Mr. Lendi – present.

Motion by Mr. Dostatni to approve the minutes of the meeting of December 20, 2012 and January 3, 2013; seconded by Mr. Lendi. AYES ALL. Motion carried.

Change Order No. 2 for the Monon Bike Trail Project, Change Order No. 2 for the 163rd Place Project, and Change Order No. 1 for the Heartland Homes Paving Project submitted by Nies Engineering, Inc. Mr. Dostatni advised the Heartland Homes Paving Project is a reduction cost of \$15,141.40, the Monon Bike Trail Project change order is a reduction in cost of \$500.10 and the 163rd Place change order is a reduction in cost of \$38,248.03. Motion by Mr. Dostatni; seconded by Mr. Lendi. AYES ALL. Motion carried. (Ins. No. 13-016)

Change Order No. 2 for the 120th Street from Calumet Avenue to Warwick Avenue and Benjamin Place from Warwick Avenue to Roosevelt Drive submitted by RW Armstrong. Mr. Dostatni advised this change order is an increase in cost of \$23,260.98 for water system changes. Motion by Mr. Dostatni; seconded by Mr. Lendi. AYES ALL. Motion carried. (Ins. No. 13-017)

License Agreements with Speedway SuperAmerica, LLC, 6845 Calumet Avenue and 7345 Kennedy Avenue for environmental monitoring submitted for approval. Motion by Mr. Dostatni; seconded by Mr. Lendi. AYES ALL. Motion carried. (Ins. No. 13-036)

Correspondence received from Mr. Gary Gleason, Street Commissioner, regarding the request for speed limit signs and stop sign placement on 114th Street. Mr. Gleason stated the speed limit signs will be placed and the speed vehicle travel needs to be addressed to the Hammond Police Department. Motion by Mr. Dostatni to approve the speed limit sign request and the refer the speed issue to the Hammond Police Department; seconded by Mr. Lendi. AYES ALL. Motion carried. (Ins. No. 13-037)

Correspondence received from Mr. Joseph Boguszewicz, 2006 Benjamin Place, requesting a "No Parking from Here to Corner" sign be placed on Calumet Avenue, north of 120th Street. Motion

by Mr. Dostatni to refer this matter to the Street Department; seconded by Mr. Lendi. AYES ALL. Motion carried. (Ins. No. 13-038)

Agreement to Restrict Use of Property submitted for approval by Attorney Curtis Vosti. Mr. Lendi advised this agreement has been reviewed by Ms. Kantar. Motion by Mr. Lendi to approve; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 13-039)

Hearing regarding Mr. Thomas Markovich. Mr. O'Connor advised the hearing will take place at the end of the meeting. Mr. O'Connor then recused himself from the meeting.

Under Meeting Opened to the Public, Councilman at Large Robert Markovich appeared and stated that he was almost hit again at Clark School and requested something be done about this issue. Mr. Markovich also said that he agreed with the citizen who requested a "No Parking from Here to Corner" sign be placed on Calumet Avenue.

Mr. Jesus Villcana, property owner of 851 Indiana Street, appeared. Mr. Villacana requested the matter regarding the property, set for earlier in the meeting, be heard. Mr. Kearney stated a contractor had pulled a permit to remove the second apartment but instead installed fire separation between units. Mr. Villacana then said he believes this building should be grandfathered instead of having to meet current code. Mr. Villacana produced architectural drawings and gave them to Mr. Kearney. Mr. Kearney requested this matter be continued. Recommendation by Mr. Lendi to rescind the order entered earlier in the meeting regarding this property and to continue this matter to February 14, 2013; Mr. Dostatni concurred.

Mr. Lendi stated that a short recess would be taken prior to the start of the Hearing regarding Thomas Markovich.

There being no further business to come before the Board, motion by Mr. Lendi to adjourn; seconded by Mr. Dostatni. The regularly scheduled meeting adjourned at 9:28 a.m.
