## MINUTES BOARD OF PUBLIC WORKS AND SAFETY AUGUST 1, 2013

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:00 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Lendi –present; Mr. Dostatni – present; Mr. Member – present.

Motion by Mr. Dostatni to approve the minutes of the meeting of July 25, 2013; seconded by Mr. Smith. AYES ALL. Motion carried.

Bid recommendation received from NIES Engineering, Inc. for the Willard Road Reconstruction Project to Walsh & Kelly, Inc., low bidder at \$705,645. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-749)

Correspondence received from DLZ Indiana, Inc. regarding the Hammond/Purdue Calumet Outdoor Athletics Complex at Dowling Park. Mr. Lendi stated the bids are rejected as the City of Hammond in unable to acquire certain property necessary for this project. Mr. Dostatni said the project will be rebid. Mr. Kearney stated this is a four (unit) building currently. Mr. Villicana said that he did provide drawings as requested, had an inspection done and obtained permits to begin rehabilitation. Mr. Villicana then said an inspector came and stopped work on the property. Mr. Koch said work was being done upstairs and the permit was issued to remove the basement apartment which is why work was stopped. Mr. Villicana stated that he did have permits to perform the work and will remove the basement apartment but does not want to convert the second floor to one apartment. Mr. Koch stated this lot is not zoned as a three (3) unit dwelling. Mr. Koch then said the drawings that Mr. Villicana provided were not good enough. Mr. Dostatni said the drawing do show two (2) units on the second floor and asked if all parties could meet to determine if a solution can be reached. Mr. Kearney stated there is an egress problem and Mr. Koch said a three (3) unit would need a sprinkler system. Motion by Mr. Dostatni to vacate the Findings and Order previously entered; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 13-755)
