Motion by Mr. Dostatni to defer the minutes of February 6, 2014 and February 13, 2014; seconded by Mr. Smith. AYES ALL. Motion carried.

Existing Right-of Way Report for 165<sup>th</sup> Street received from Beam Longest and Neff, LLC, Motion by Mr. Dostatni to approve; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 14-094)

Notice of Violation on property located at 1714 Atchison Avenue. Property owner fails to appear. Mr. Nick Farrell, Inspector, Inspections Department, requests the removal of the second floor apartment and for the basement to be finished. Mr. Farrell then stated that Fannie Mae is the owner and is selling it as a single family home. Mr. Farrell then requested a Deed Restriction. Corporation Counsel, Ms. Kristina Kantar, stated that a Deed Restriction must be signed by both parties and suggested an Order to Remove be executed. Rental registration hearing on the property located at 6619 Madison Avenue. Property owner Ms. Beverly Collier, appears and stated she was unaware of the fee and that she has never received any information about it. Ms. Collier then said she has lived there for nine (9) years and was going to rent the three (3) bedroom house but decided not to after applying for Section 8 and not being accepted. Corporation Counsel Kristina Kantar state there are police reports from August of 2013 for that property which stated Ms. Priscilla Gutierrez and Ms. Judy Jones both lived at 6619 Madison Avenue at that time. Ms. Collier stated Ms. Jones is the previous owner. Ms. Collier states no one rented the house. Ms. Collier stated Ms. Gutierrez was at the property as she was interested in renting it. Ms. Collier let her stay there at the property temporarily but she was denied Section 8 so she was unable to rent it to her. Ms. Kantar then advised the water bill has been in the tenants name from October 2012 until October 2013. Motion by Mr. Smith to assess the \$80 rental registration for two (2) years and one (1) late fee of \$500; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 14-101)
