## <u>MINUTES</u> BOARD OF PUBLIC WORKS AND SAFETY <u>MARCH 6, 2014</u>

The regularly scheduled meeting of the Board of Public Works & Safety convened at 9:00 a.m., in Council Chambers of Hammond City Hall. A roll call was taken: Mr. Lendi –present; Mr. Dostatni – present; Mr. Smith – present.

Motion by Mr. Dostatni to defer the minutes of the February 27, 2014 meeting; seconded by Mr. Smith. AYES ALL. Motion carried.

Agreement received from Baxter & Woodman, Inc. Consulting Engineers for the 2014 1st District Roadway Improvements of Wabash Avenue - 141st Street to 139th Street - submitted for approval. Mr. Dostatni advised this is the final phase of the project and the cost will be \$1,423,364. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. No. 14-120)

Four (4) Change Orders from received from American Structurepoint for the 169th Street project submitted for approval. Mr. Dostatni said this project is 80% federally funded and has been approved. Mr. Dostatni then advised the change orders represent mainly water main repair and storm sewer repair costs. Motion by Mr. Dostatni; seconded by Mr. Smith. AYES ALL. Motion carried. (Ins. Correspondence received from Assistant Chief of Police John Doughty requesting approval of the retirement of Chief of Police Brian Miller effective April 1, 2014. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 14-124)

Mr. Welch stated he will salvage most of the garage material. Mr. Kearney said he will check on the condition of the garage. Motion by Mr. Smith to set this matter for status on March 13, 2014; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 14-127)

Hearing on property located at 627 Kane Street. Attorney Cordell Funk appears for the property owner, Mr. Leonardo Ventura. Mr. Matt Saliga, Inspector, Inspections Department, requested the second floor apartment be removed and also that the Board affirm the Findings and Order regarding the property. Mr. Funk said he has attempted to reach Mr. James Callahan, Chief of Inspections, but has not been successful. Mr. Funk also stated his client will cooperate with the City. Motion by Mr. Smith to affirm the Findings and Order; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 14-128)

Correspondence received from Megan Flores of the Jean Shepherd Community Center requesting J.F. Mahoney Drive become a one-way traveling East for the two (2) days, Sunday March 15, 2014 and Sunday, March 16, 2014 for TwistStars Tumbling and Trampoline Pot O' Gold Invitational submitted for approval. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 14-129)

Under Matters from Other board Members, Mr. Lendi requested a letter be sent to 3<sup>rd</sup> District Councilman Anthony Higgs advising that no action has been taken in regard to 918 Highland Street as of March 5, 2014.

Under New Business, Attorney Jamie Driscoll appeared presented an Agreement for 1909 Clay Street and 1903 Clay Street that has been approved by Corporation Counsel Kristian Kantar. Mr. Driscoll then said the property owner will pay a \$5,000 bond and also pay for the cut and clean liens. Motion by Mr. Smith; seconded by Mr. Dostatni. AYES ALL. Motion carried. (Ins. No. 14-130)

Under Meeting Opened to the Public, the property owner of 1150 Summer Street stated that he received letter from Smith Sersic regarding the demolition of his property. The property owner said he was not notified and the previous owner had signed an Agreement to rehabilitate the property. Mr. Kurt Koch, Commissioner, Building Department, said the Agreement has expired and Ms. Kantar advised the Agreement should not be renewed. The property owner said the City has not followed Indiana Code.

There being no further business to come before the Board, recommendation by Mr. Dostatni to adjourn; Mr. Lendi concurred. The regularly scheduled meeting adjourned at 9:17 a.m.
