Motion by Mr. Smith to nominate Mr. Edward Krusa to be the President of the Board of Public Works & Safety; seconded by Mr. Krusa. AYES ALL. Motion carried.

Under Matters from Other Board Members, Mr. Dostatni received a Covenant of Use indicating the property located at 264 Lawndale Street will be used as a single family residence. Motion by Mr. Smith; seconded by Mr. Krusa. AYES ALL. Motion carried. (Ins. No. 14-314)

Mr. Smith responded to an inquiry from Mr. Alvin Cheeks regarding his request for a stop light on 143<sup>rd</sup> Street and Calumet Avenue. Mr. Smith advised there have been only two (2) accidents there in the last fourteen (14) years.

Mr. Cheeks addressed the Board and said there are three (3) businesses on Columbia Avenue that do not have business licenses, he would like to place a plaque on the land his mother owns at George Lake and that Redevelopment controls Lost Marsh.

Mr. Kenneth Hayes, owner of a business located at 6225 Kennedy Avenue, appeared and stated that he thought he had a hearing today before the Board regarding the revocation of his Business License. Ms. Kantar advised the hearing for this business is set for May 15, 2014.

Mr. Howard Johnson then addressed the Board. Mr. Johnson stated that he would like to save the property located at 504-06 Kenwood Street and that he has spoken to Mr. Caleb Johnson, property owner, regarding the purchase of this property. Ms. Kantar advised the porch is failing and the interior walls are falling. Mr. Johnson asked the demolition be delayed by thirty (30) days to allow him time to inquire about purchasing the property. Motion by Mr. Krusa to continue this matter to June 12, 2014; seconded by Mr. Smith. AYES ALL. Motion carried.

There being no further business to come before the Board, motion by Mr. Dostatni to adjourn; seconded by Mr. Smith. The regularly scheduled meeting adjourned at 10:07 a.m.
