

**BOARD OF PUBLIC WORKS AND SAFETY**  
**MINUTES OF SEPTEMBER 3, 2015**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:02 a.m. on Thursday, September 3, 2015, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Krusa - present; Mr. Dostatni - present; Mr. Smith- present.

Motion by Mr. Dostatni to approve the Minutes of August 13, 20 & 27, 2015; seconded by Mr. Smith. AYES ALL. Motion carried.

Bid tabulation and award recommendation from United Consulting for the Northcote Avenue Lighting Improvements from Southeastern Avenue to 169th Street submitted for approval.
