Contract with Midwestern Electric, Inc. for the Northcote Avenue Lighting Project - Southeastern Avenue to 169th Street Project. Motion by Mr. Smith; seconded by Ms. Garay. AYES ALL. Motion carried. (Ins. No. 15-967)

Bid recommendation letter received from Clark Dietz Engineers for the 2nd District Lighting Project – Elm Avenue, Hickory Avenue, Catalpa Avenue and Chestnut Avenue to low bidder, Midwestern Electric. Motion by Mr. Smith; seconded by Ms. Garay. AYES ALL. Motion carried. (Ins. No. 15-968)

Hearing on property located at 851 Gostlin Street. Property owner fails to appear. Corporation Counsel Kristina Kantar said Attorney David Weigle is representing the property owner and he appeared earlier but has since left. Ms. Kantar requested this property be bid for demolition as the garage is in an unsafe condition. Motion by Mr. Smith; seconded by Ms. Garay. AYES ALL. Motion carried. (Ins. No. 15-973)

Demolition of property located at 728 118th Street. Property owner appears and said he

would like to make repairs but he did not have insurance coverage on the structure. Ms. Kantar said this is the second fire at this property. Mr. Kurt Koch, Commissioner, Building Department, said the building is not sound, the repair cost would be approximately \$80,000 and code will not allow a rebuild as it was a non-conforming of the property. The property owner said he has \$30,000 invested in the property. Mr. Dostatni told the property owner to work with the Building Department and fence the area around the property immediately. Ms. Kantar then requested the Board affirm the Order to Demolish. Motion by Mr. Smith to affirm the Order to Demolish but stay to November 12, 2015; seconded by Ms. Garay. AYES ALL. Motion carried.
