MINUTES BOARD OF PUBLIC WORKS AND SAFETY NOVEMBER 5, 2015

Under Meeting Ms. Melissa Benavidez, property owner of 7230 McCook Avenue, requested additional time after not being able to pay her rental registration fees assessed at a hearing before the Board.
