MINUTES BOARD OF PUBLIC WORKS AND SAFETY DECEMBER 3, 2015

Motion by Mr. Smith; seconded by Ms. Garay. AYES ALL. Motion carried. (Ins. No. 15-1057)

Mr. Smith advised there will be no Board of Public Works & Safety meeting held on Thursday, December 24, 2015.

Under Meeting Opened to the Public, Mr. Donald McBride, property owner of 7431 Chestnut Avenue, said he just paid for an inspection today and the property was bid for demolition today. Ms.

Kantar responded that the demolition process moves forward until an agreement is signed for rehabilitation of the property.

Mr. Robert Kuel, contractor for the property owner of 3306 165th Street, appeared before the Board and requested another rehabilitation agreement be signed as the original has now expired. Mr. Dostatni asked if the property owner was at the meeting as he or she would be the person to sign another agreement. The property owner then stood up and acknowledged that he knew his signature would be necessary. Mr. Kelly Kearney, Commissioner, Code Enforcement, said the foundation in the southwest corner of the house is gone and must be repaired. Mr. Kuel said that he has that corner supported. Ms. Kantar then said until another agreement is signed, this property will proceed with the demolition process until that time.

Ms. Ruth Mores, 240 Southmoor Road, appeared and said there is vacant lot on the corner of 173rd Street and Lyman Avenue that is being used as a party spot and dumping ground. Ms. Mores said she, and neighbors, have contacted the police but that has not solved the problem. Ms. Mores then requested signage, such as Authorized Vehicles Only, as she is aware NIPSCO needs access, or No Trespassing, be placed. Mr. Dostatni said he believes CSX may own the property and will have be to contacted regarding placing signs or blocking access completely. Mr. Dostatni requested that the Law Department send a letter to CSX regarding this issue.

There being no further business to come before the Board, motion by Mr. Smith to adjourn; seconded by Ms. Garay. The regularly scheduled meeting adjourned at 9:39a.m.
