Attorney Kevin Smith also appeared for the City of Hammond. Mr. Dostatni asked if there was anyone in the audience who wanted to speak on any of the properties listed in the Blight Elimination Program notice. There was no response from the audience. Ms. Kantar then said she received no response to an email she sent on April 8, 2016 to Ms. Rogers. Ms. Rogers said that she did receive the email. Ms. Kantar then said there are animal feces over the entire house, that NIPSCO has been cut and water service has probably been shut off. Mr. Kelly Kearney, Chief of Inspections, said the property is an illegal two (2) unit, permits have been issued and a contract for demolition has been signed. Motion by Ms. Garay to deny the request for rehabilitation of property and to proceed with demolition; seconded by Mr. Margraf. AYES ALL. Motion carried.
