BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF MAY 12, 2016

Motion by Ms. Garay to defer approval of the minutes of the meeting of October 29, 2015; seconded by Mr. Margraf. AYES ALL. Motion carried.

Mr. Kearney said the property is an illegal two (2) unit and that due to the amount of cat feces covering the interior of the property he will not allow an inspector to go in. Ms. Kantar said a demolition order and permits have already been issued. Ms. Fisher requested a two (2) week stay of the demolition order. Correspondence received from a Very Concerned Hammond Senior Resident requesting action be taken on vehicles parking on both sides of the 7400 block of Harrison Avenue, vehicles not stopping at the stop sign at 175th Street and Harrison Avenue, garbage in the alley and grass not being mowed. Motion by Ms. Garay to refer this correspondence to Public Works, Inspection Department and the Hammond Police Department; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 16-332)

Ms. Kantar requested the Board go back to the request from the HC3 Board of Directors. Ms. Kantar asked if any part of Kennedy Avenue was requested to be closed. Mr. Gleason said that Kennedy Avenue will be closed during the time there is a parade by EMA which was done last year. Mr. Dostatni then requested the first action taken on the Live in the Ville Fest be rescinded and notify the HC3 Board of Directors to contact Mr. Gleason in order to give more specific requests. Motion by Ms. Garay to have the HC3 Board of Directors to contact Mr. Gleason to give specific requests to the Board; seconded by Mr. Margraf. AYES ALL. Motion carried.

Under Meeting Opened to the Public, 3rd District Councilman Anthony Higgs said he received a letter regarding the condition of property at the corner of 169th Street and Reverend Burns Drive. Mr. Keaney said a court order for a cut and clean will be needed before any work can be done there as it is private property.

Mr. Higgs then requested the property owner of the house on the 900 block of May Street that has a fallen tree on the property either cited or have the tree removed.

Mr. Higgs then said he has twice personally paid to have the property at 838 Carroll Street cleaned. Ms. Garay said that property is on the Blight Elimination Program and should be demolished soon.

Mr. Higgs then said he had submitted a request for street closure for the basketball tournament he sponsors. Mr. Dostatni said that request was approved last week.

There being no further business to come before the Board, motion by Ms. Garay to adjourn; seconded by Mr. Margraf. The regularly scheduled meeting adjourned at 9:57 a.m.
