Motion by Ms. Garay to approve the minutes of the meeting of October 29, 2015 and November 5, 2015; seconded by Mr. Margraf. AYES ALL. Motion carried.

Proposal for Around Town Charging Station Installation submitted by EMCOR Hyre Electric. Mr. Dostatni advised the charging station is being paid for by a grant and the City will only be responsible for NIPSCO. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. Requests for Permit received from Construction-CAD Solutions, Inc. for the installation of WOW fiber optic cable on 165th Street to feed Verizon Cell Towers. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 16-366)

Demolition hearing on property located at 5526 Beall Avenue. Property owner fails to appear. Ms. Kantar said the two (2) story frame house has broken, rotted windows, there is a large dead tree in the front years and a window air conditioner is held up by 2x4's. Ms. Kantar then requested the Board enter the Order to Demolish. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 1010 Chicago Street (garage only). Ms. Kantar advised the garage has been self-demolished and requested this file be closed. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 1020 Chicago Street (garage only). Ms. Kantar advised the garage has been self-demolished and requested this file be closed. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 6239 Harrison Avenue. Attorney Driscoll sent

correspondence advised the property owners have paid for an inspection and would like to enter into a rehab agreement. Motion by Ms. Garay to s continue this matter to August 18, 2016; seconded by Mr. Margraf. AYES ALL. Motion carried.

Ms. Kantar said the frame house has missing siding, debris in the yard, a large dead tree, boarded up windows, rear yard is full of debris and the shed in the back yard is rotting. Ms. Kantar requested the Board enter the Order to Demolish but stay issuance of permits until the status hearing date of August 18, 2016. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 6857 Kennedy Avenue. Property owner appears and said there is a pending contract sale due to close in August. Ms. Kantar said the property, a vacant car wash, has debris in the drive areas and requested the Board enter the Order to Demolish but stay issuance of permits until August 25, 2016 to allow sale to occur. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 1023 - 1025 Kenwood Street. Property owner representative, Bishop Wallace Johnson of Taliefero/Emmanuel Temple Church, appears and said there is an interested buyer who will demolish the building. Ms. Kantar said the lot is garbage filled which hides a garage that is missing an entire wall. Ms. Kantar requested the Board enter the Order to Demolish but stay issuance of permits until August 18, 2016 to allow sale to occur. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 7206 Maryland Avenue. Property owner, FBNI, fails to appear. Ms. Kantar said the property is boarded up due to fire damage and the yard is unmaintained. Ms. Kantar then requested the Board enter the Order to Demolish. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 1047 Moss Street. Ms. Kantar advised the garage has been self-demolished and requested the file be closed. Motion by Ms. Garary; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 6518 Parrish Avenue. Attorney John Dull appears for the property owners and said the property owners are interested in signing a rehab agreement and will call for an inspection. Ms.Kantar said the property has a rotted tarp on the roof, soffit and fascia are rotted, boarded up back door and the garage is boarded up with a failing roof. Ms. Kantar then requested the Board enter the Order to Demolish but stay issuance of permits until August 18, 20156 to allow time for an inspection to be done and a rehab agreement to be signed. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 5533 Sohl Avenue. Property owner appears and said he has been working on the house. Ms. Kantar said the property is fire damaged, boarded up and the roof is failing. Ms. Kantar advised the property owner that an inspection needs to be done, a rehab agreement signed and permits need to be obtained before any other work is done. Ms. Kantar then requested the Board enter the Order to Demolish but stay issuance of permits until August 18,

2016 to allow inspection and rehab agreement to be completed. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 5639 Sohl Avenue. Ms. Kantar advised this property is on the Hardest Hit listing and is awaiting demolition.

Demolition hearing on property located at 607 Thornton Street. Attorney Bryan Redmond appears for the lender, said the bank will charge off the loan and has not objection to demolition. Ms. Kantar requested the Board enter the Order to Demolish. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried.

Demolition hearing on property located at 6921 Van Buren Avenue (garage only). Attorney Redmond appears and said the house is going up on Sheriff sale on June 3, 2016 and if bank wins bid, it will repair or demolish the garage. Ms. Kantar said the garage is collapsing, the roof has failed and part of the gutter is hanging in the yard. Motion by Ms. Garay to continue this matter to August 18, 2016; seconded by Mr. Margraf.
