Mr. Rodriguez said the parade route requested would block Kennedy Avenue from 167th Street to 169th Street, the after parade festivities would include food, beer garden and music on 167th Street. Mr. Margraf said Hammond Fire Department ambulances use Kennedy Avenue to get to St. Catherine's in East Chicago which may present a problem. Mr. Margraf requested this matter be deferred to allow the Fire Department to determine an ambulance route. Motion by Ms. Garay to defer this matter; seconded by Mr. Margraf. AYES ALL. Under Meeting Opened to the Public, Mr. Hernandez, property owner of 6239 Monroe Avenue, appeared and requested a time extension as he is doing the work himself. Corporation Counsel, Ms. Kristina Kantar, said she will draft the extension and mail it to Mr. Hernandez today.
