MINUTES BOARD OF PUBLIC WORKS AND SAFETY JUNE 1, 2017

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:01 a.m. on Thursday, June 1, 2017, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Dostatni – present; Ms. Garay – present; Mr. Margraf – present.

Motion by Mr. Margraf to approve the minutes of April 27, 2017seconded by Ms. Garay. AYES ALL. Motion carried.

Correspondence received from Mayor McDermott, Jr. allocating \$14,000 of Mayor's 2017 Gaming Funds to the Pedestrian Traffic Signal Improvement Design Contract, Calumet Avenue and River Drive. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 17-456)

Agreement with First Group Engineering, Inc. for design engineering for the Pedestrian Traffic Signal Improvement – Calumet Avenue and River Drive at a cost of \$14,000. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 17-457)

Under Matters from Board Members, Mr. Dostatni received correspondence from Norfolk Southern Corporation regarding a noise complaint lodged by a Hammond resident. Mr. J.R. Fleps, Division Engineer, Norfolk Southern Corporation, said the location of the noise reported is occurring at a railroad interlocking, which is a point at which trains diverge track to track and may generate more noise than straight track. Mr. Fleps then said the location is inspected twice per week to assure safe passage of trains. (Ins. No. 17-483)

Correspondence received from Rieth Riley Construction Co., Inc. requesting Pine Avenue and Oak Avenue be converted to two (2) way traffic from Hoffman Street to Chicago Street and "No Parking" signs on the school side of the street for Pine Avenue and Oak Avenue adjacent to Washington Irving Elementary until November 22, 2017 for the Chicago Street project. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 17-484)

Animal Control Officer, Ms. Deanna Lugo, appeared before the Board. Ms. Lugo said on May 11, 2017 a cane corso dog and two (2) male cane corso puppies were caught running loose. Ms. Lugo said the owner, Mr. Maurice Evans, was notified, contacted Animal Control and was told the dogs would be held until the court date of May 24, 2017. Mr. Evans appeared in court on May 24, 2017 and was told by Judge Foster to secure his fence, get pre-paid rabies vaccinations and pay impoundment fees by June 1, 2017. Ms. Lugo then said Mr. Evans contacted Animal Control yesterday and was argumentative on the phone. Ms. Lugo then requested the dogs become the property of the City of Hammond's Animal Control Department. Motion by Ms. Garay to declare the dogs abandoned and for the Law Department send Mr. Evan's correspondence advising him of the action; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. Correspondence received from 2nd District Councilman Pete Torres requesting a stop sign be placed on the corner of Michigan Street and Walnut Avenue and "One Way" signs on Summer Street and Grant Avenue south bound. Motion by Ms. Garay to refer this matter to Public Works; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 17-486)

Agreement with VS Engineering, Inc. for engineering services in the Columbia Park Trail project at a cost of \$44,600. Motion by Ms. Garay; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 17487)
