MINUTES BOARD OF PUBLIC WORKS AND SAFETY JUNE 8, 2017

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:00 a.m. on Thursday, June 8, 2017, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Dostatni – present; Ms. Garay – absent Mr. Margraf – present.

Due to the absence of Ms. Garay, normal rules of procedure are suspended.

Recommendation by Mr. Margraf to approve the minutes of the meeting of May 4, 2017; Mr. Dostatni concurred.

Corporation Counsel, Ms. Kristina Kantar, requested the Business License denial to Andrews Automotive be heard first. Attorney Tom Kirsch, appears with Mr. Andrews. Mr. Kirsch presented an Affidavit by Ms. Daisy Andrews which stated she is the sole owner of the business. Ms. Kantar said while Mr. Andrews, late husband of Ms. Andrews, estate was in probate court there was an ownership dispute. Mr. Kirsch said Ms. Andrews is now the sole owner and she has health concerns which prevent her from personally being at the business. Mr. Kirsch then said that Mr. Andrews, son of Ms. Andrews, does have a criminal record. Mr. Kirsch then said the cars that are currently on the business lot will be towed away today.
