<u>MINUTES</u> BOARD OF PUBLIC WORKS AND SAFETY JUNE 29, 2017

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:07 a.m. on Thursday, June 29, 2017, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Dostatni – present; Ms. Garay – present; Mr. Margraf – present.

Motion by Mr. Margraf to approve the minutes of the meeting of May 11, 2017 and May 18, 2017; seconded by Ms. Garay. AYES ALL. Motion carried.

Bid opening – Demolition of 1021 169th Street (rear only), 1236 175th Street, 7909 Belmont Avenue, 7622 Catalpa Avenue (garage/shed only), 4137 Dearborn Avenue, 4415 Henry Avenue, 7222 Jackson Avenue, 4409 Johnson Avenue, 2824 New York Avenue, 7149 Ontario Avenue, 7449 Parrish Avenue, 1527 River Drive, 7015 – 17 Van Buren Avenue, 636 Willow and 704 Willow Court.
