

**BOARD OF PUBLIC WORKS AND SAFETY**  
**MINUTES OF FEBRUARY 1, 2018**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:01 a.m. on Thursday, February 1, 2018, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Dostatni - present; Ms. Garay - absent Mr. Margraf- present.

Due to the absence of Ms. Garay, normal rules of procedure are suspended.

Recommendation by Mr. Margraf to defer approval of the minutes of the meeting of January 25, 2018; Mr. Dostatni concurred.

Bid recommendation received from United Consulting for the Street Lighting Project – Alabama St. from 173rd St. to 175th St., Arizona from 173rd St. to 175th St., Delaware Avenue - south of Orchard Drive and Carolina Avenue from Orchard Drive to 174th Court be awarded to the low bidder, Hawk Enterprises for \$518,661.30.
