The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:01 a.m. on Thursday, September 20, 2018, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay - present; Mr. Margraf – present; Mr. Long – present.

Motion by Mr. Margraf to approve the minutes of the meeting August 23, 2018; seconded by Mr. Long. AYES ALL. Motion carried.

Correspondence received from Chief of Police John Doughty advising Sergeant Keith Markert and Corporal John Riordan are no longer performing the duties of a Field Training Officer and will relinquish FTO Specialty Pay, the termination of Correctional Officer Michael Delnick and Disposal Authorizations submitted for approval. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 18-784) Property owner of 2123 Sherman Street stood up and said that he has an unrecorded land contract for the purchase of the property but cannot get signature from the current owners as they are in jail. Mr. Kelly Kearney, Chief of Inspections, said the property may qualify for Hardest Hit funds if demoed. Mr. Kearney advised the property owner to speak with him after the meeting.

Mr. John Latko, property owner of 18 Elizabeth Street, then addressed the Board. Mr. Latko said there was a small fire at the property and he has medical issues preventing him from doing any work on the property. Mr. Latko then said he has a number of people interested in buying the property from him and requested additional time to make repairs or sell. Mr. Kearney advised that Mr. Latko is in no jeopardy of the structure being demolished in the near future. Mr. Latko then gave a note from his doctor which said he is not to work in heat or do any strenuous work. Mr. Latko requested the Board furnish him with a letter stating the property would not be demolished within the next sixty (60) days. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Ms. Garay received correspondence from 5th District Councilman Dave Woerpel requesting \$50,000 of gaming funds be allocated for park improvements and tree removal and trimming in the 5th District. Ms. Garay said the Mayor has not yet signed the document. Motion by Mr. Margraf to approve pending receipt of the Mayor's signature; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 18-804)

Under Meeting Opened to the Public, the property owner of 7212 Southeastern Avenue requested a forty five (45) day extension of the Agreement to Rehabilitate to allow time to install new windows. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried.
