Mr. Howard said he has issue with some of the requirements on the Agreement to Rehabilitate the property.

Ms. Kantar replied that the house has been vacant for quite some time, the roof has failed, Mr. Howard needs a licensed contractor to make the repairs as he will not be living there, he failed to show for a scheduled inspection in April of this year, received an Agreement to Rehabilitate which is not yet signed and the property must be repaired to code by a Hammond licensed contractor.

Ms. Garay asked Mr. Howard if he had a contractor to which Mr. Howard said that he did and the contractor is licensed in Gary.

Mr. Kearney said Mr. Howard wants to renegotiate the Agreement to what is acceptable to him. Mr. Kearney said he will meet with Mr. Howard and his contractor, Michael Clay, who is licensed in Gary. Mr. Howard and Mr. Kearney then agreed on meeting on Monday, October 1, 2018 at 11:00 a.m. with Mr. Howard's contractor.

Property owner of 2123 Sherman Street appeared and said he does not yet have a recorded deed and that he may self- demolish. Mr. Kearney said he will give him Attorney Nicole Bennett's phone number as she is the contract for Hardest Hit homes.

Mr. Don Kalina, Hammond EMA, with the owners of Schoop's, Hamburgers, 7235 Indianapolis Boulevard, appeared before the Board. Mr. Kalina said Hammond Animal Control is requesting permission to put a tent in the parking lot of Schoop's Hamburgers, on Sunday, September 30, 2018 for a fundraiser, EMA will help with traffic if necessary, Car X, has agreed to allow Schoop's customers to park in their lot and there will be animals there from 5:00 p.m. to 7:00 p.m. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried.
