

**BOARD OF PUBLIC WORKS AND SAFETY**  
**MINUTES OF FEBRUARY 7, 2019**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:05 a.m. on Thursday, February 7, 2019, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Gary – present; Mr. Margraf – present; Mr. Long – present.

Motion by Mr. Margraf to approve the minutes of the meetings of January 17, 2019 and January 24, 2019; seconded by Mr. Long. AYES ALL. Motion carried.

Request for advertising dates of February 14, 2019 and February 21, 2019 with a bid opening date of March 7, 2019 for the 6th District Local Street Project – Alabama Avenue between Downey Place south to dead end, Rhode Island Avenue between 165th Street south to dead end and Ohio Avenue between 165th Street south to dead end Lighting Improvements. Ms. Kantar said the work that was done without permits needs additional work by a qualified contractor. Ms. Kantar then requested this matter be continued to March 21, 2019. Motion by Mr. Margraf to continue this matter to March 21, 2019; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-061)

Correspondence received from Mr. Michael Boyer, 817 173rd Street, requesting an appeal of the decision to turn the alley from 173rd Street northbound to 171st Street to two (2) way. Mr. Jonathan Parker, Engineering Department, said over 50% of residents/businesses approved the change. Mr. Kelly Kearney, Chief of Inspections, said the alley was changed to one (1) way due to a carwash on the block. Motion by Mr. Margraf to refer this matter to City Council as an ordinance will have to be passed in order to make the change permanent; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-068)

Under Matters from Department Heads/Their Representatives, Mr. Kearney requested an Emergency Demolition be declared on property located at 2700 – 165<sup>th</sup> Street due to a recent fire. Mr. Kearney then requested JM Industrial Services be awarded the demolition. Motion by Mr. Margraf to declare this an Emergency demolition and for JM Industrial Services to perform the demolition; seconded by Mr. Long. AYES ALL. Motion carried.
