

BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF MAY 30, 2019

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:01 a.m. on Thursday, May 30, 2019, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay – present; Mr. Margraf – present; Mr. Long – present.

Motion by Mr. Margraf to approve the minutes of the meeting of May 2, 2019; seconded by Mr. Long. AYES ALL. Motion carried.

Contract with HWC Engineering for the 5th District Lighting Project – Arkansas Avenue from 173rd Street to 175th Street, California Avenue from 173rd Street to 175th Street and Colorado Avenue from 173rd Street to 175th Street at a cost not to exceed \$65,333.00. Motion by Mr. Long; seconded by Mr. Margraf. AYES ALL. Motion carried. (Ins. No. 19-335)

Correspondence received from Mr. Dean Button, City Engineer, requesting the at-grade crossing of the NICTD tracks at the 4500 block alley of Hohman Avenue be closed due to limited visibility and no automatic gates at this location. Mr. Button said he has spoken with several department heads who are in agreement with the closure. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-336)

Correspondence received from Indiana Harbor Belt Railroad Company requesting Indianapolis Boulevard at 165th Street be closed from June 3, 2019 through June 8, 2019 to replace two (2) tracks. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-337)

Correspondence received from Walsh & Kelly, Inc. requesting permission to detour traffic on McCook Avenue at 164th Place to complete installation of a 24” storm sewer from Friday, May 31, 2019 through Friday, June 21, 2019. Ms. Garay said the Board has no control over how subcontractors are paid and wording in the letter indicates the law firm may want to submit a request for public record. Motion by Mr. Margraf to advise Douglas, Koeppen & Hurley to contact the contractor directly and if other information is needed a request for; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. Correspondence received from Chief of Police John Doughty submitting the Petition for Retirement from Sergeant David Willoughby at the close of business on June 21, 2019 and approval of Detective Sergeant John Riordan to receive Specialty Pay for completing the Indiana Law Enforcement Academy's Emergency Vehicle Operations basic instructor course. Motion by Mr. Margraf; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-343)

Rental registration hearing on property located at 1622 175th Street. Property owner, Mr. John Grunewald, appears, said in 2017 and 2018 there was a tenant and the property has been vacant in 2019. Mr. Kelly Kearney, Chief of Inspections, appears for the City of Hammond and said there have been no issues with the property. Mr. Kearney requested the property owner complete affidavits for 2017 and 2018 and that there are no issues with the property. Motion by Mr. Margraf to have the property owner complete affidavits for 2017 and 2018 regarding the property being vacant; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-347)

Rental registration hearing on property located at 7619 Catalpa Avenue. Property owner appears, said he has paid rental registration in 2019 which is how he has been made aware that that 2017 and 2018 have not been paid. Mr. Kearney said there have been no issues with the property and requested the late fee be waived. Rental registration hearing on property located at 3020 165th Street. Property owner fails to appear. Mr. Kearney said the property was vacant in 2018 and rental registration was paid for 2019. Motion by Mr. Margraf to have the property owner complete an affidavit for 2018; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-351)

Rental registration hearing on property located at 842 State Street. Property owner appears by Mr. Alexander Smith who lives in one (1) unit of the two (2) unit property. Mr. Kearney said 2018 and 2019 are owing and there are no issues with this property. Motion by Mr. Margraf to waive the late fee and assess rental registration at \$5 per unit for 2018 and \$5 per unit for 2019; seconded by Mr. Long. AYES ALL. Motion carried. (Ins. No. 19-352)
