

**BOARD OF PUBLIC WORKS AND SAFETY**  
**MINUTES OF JUNE 20, 2019**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:02 a.m. on Thursday, June 20, 2019, in the Council Chambers of Hammond City Hall. A roll call was taken: Ms. Garay – present; Mr. Margraf – present; Mr. Long – present.

Motion by Mr. Long to approve the minutes of the meeting of May 23, 2019; seconded by Mr. Margraf. AYES ALL. Motion carried.

Bid opening – 139th Street Reconstruction – Sheffield Avenue to Hohman Avenue. Bids received as follows:
