## BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF AUGUST 1, 2019

Motion by Mr. Margraf to approve the minutes of the meeting of July 11. 2019; seconded by Mr. Long. AYES ALL. Motion carried.

Contract with Dyer Construction Company, Inc. for the Sohl Avenue and Hoffman Street Multi-Use Trail Project from 700 feet North of the Grand Calumet River along Sohl Avenue to Torrence Avenue.
