

**BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF JULY 29, 2021**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:04 a.m. on Thursday, July 29, 2021, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Margraf – present; Mr. Long – present; Mr. Perez – present.

Motion by Mr. Long to approve the Minutes of the meeting of June 10, 2021, and defer the Minutes of the meeting of June 17, 2021 and June 24, 2021; seconded by Mr. Perez. AYES ALL. Motion carried.


