

BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF JUNE 30, 2022

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:03 a.m. on Thursday, June 30, 2022, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Margraf – present; Mr. Long – present; Mr. Perez – present.

Motion by Mr. Long to approve the Minutes of the meeting of June 16, 2022 and June 23, 2022; seconded by Mr. Perez. AYES ALL. Motion carried.

Under Bid Opening, State Line Closure Project at Cleveland Street, Kenwood Street, Wildwood Road and Detroit Street.

6400 block of Forest Avenue. Mr. Farrell states the inspector has been out to the property, will have 10 days to bring in compliance. Mr. Margraf questions the time line for citation. Inspector Jordan states there was nothing in front of the property at that time but other violations regarding the property were sent. Mr. Farrell states there was no evidence of a vehicle repair shop. Mr. Long requests if there are any traffic impeded or any vehicles illegally parked to call the Hammond Police. (Ins. No. 22-409)

Status - Councilman Kalwinski's request for 4-way stop at the intersection of Hohman Avenue and Huehn Street. Mr. Button states there is significant amount of construction and requests this be set for a later date. He would like to do a traffic evaluation in the Fall after construction and school starts. Councilman Kalwinski states the neighborhood has been asking for this request. This has been a fly through zone, no stop signs. Patrol officers that cross kids are constantly asking for stop signs because of near misses related to children and cars. Recently there have been accidents at Hohman and Huehn. Records from police will show this. Mr. Kalwinski is asking that this be done sooner that later instead of being referred to Engineering and respond to the neighborhood. Also believes more stop signs are needed before someone gets seriously injured. Residents' vehicles are getting hit by just sitting there. This is a concern and people want something done. He has previously asked for stop signs and stop lights, more concerned with safety than traffic counts. Mr. Margraf asks if he has statistics. Mr. Smith requests if you can look at the whole stretch. Mr. Kalwinski states that the parallel street Sheffield has a stop sign at 140th, 141st, 143rd, roundabout and a stop sign at 137th and Hohman has nothing. Mr. Button states the last 3 years of reports and counts of the accidents should be requested. Mr. Long's concern is if this is normal or just from the construction. Mr. Long will pull these. Motion by Mr. Long to set Mr. Kalwinski's request for status on July 14, 2022; seconded by Mr. Perez. AYES ALL. Motion carried.

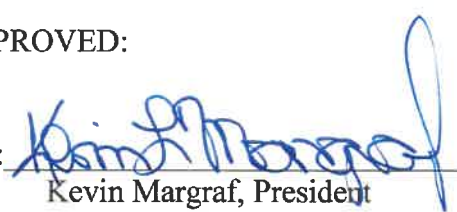
