

## **BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF AUGUST 25, 2022**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:04 a.m. on Thursday, August 25, 2022, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Margraf – present; Mr. Long – present; Mr. Perez – absent.

Due to the absence of Mr. Perez, normal rules of procedure are suspended.

Recommendation by Mr. Long to approve the Minutes of the meeting of August 18, 2022; concurred by Mr. Margraf.

Under Correspondence, correspondence received from Chief of Police, William Short requesting the approval for Officer Lindsey Fritz to receive ET Specialty Pay retroactive to July 25, 2022; Officer Kyle Wagers to receive ET Specialty Pay retroactive to July 29, 2022; Officer Ryan Zurek was transferred to the Traffic Unit and will no longer be receiving ET Specialty Pay effective August 11, 2022; submitting the resignation of Correctional Officer Halen Paz, effective the closing date of August 16, 2022. Correspondence received from City Engineer, Dean Button recommending to allow School City of Hammond staff at Burns-Hicks and Kenwood schools to place temporary barriers on Tapper Avenue, Woodward Avenue and Moraine Avenue on school days during arrival and

dismissal for a 90-day trial basis. Mr. Button states Councilman Tyler and School City requested looking into this. First Group provided a study of the traffic cross over. The recommendation is to add a temporary barrier for the traffic flow. This will not start until after the Labor Day holiday for a 90-day trial, this will give them time to notify the residents, it's for the safety of the children. Mr. Long would like to know when this begins in order to have a few squads help at first with the temporary blockage. Recommendation by Mr. Long to approve; concurred by Mr. Margraf. (Ins. Correspondence received requesting a rental registration hearing. Recommendation by Mr. Long to set for September 15, 2022; concurred by Mr. Margraf. (Ins. No. 22-522)

Right of Way Permits (1) submitted for approval from Engineering Department. Mr. Gordish gives an update on 173<sup>rd</sup> and Lyman. Water main had no casing and should be completed by September 30, 2022. Recommendation by Mr. Long to approve; concurred by Mr. Margraf. (Ins. No. 22-525)

Garage Sale Permits submitted for approval. Recommendation by Mr. Long to approve; concurred by Mr. Margraf. (Ins. No. 22-526)

Under Old Business, status – handicap parking at 5843 Columbia Ave. Councilman Tyler appears via Zoom. Ms. Deri Gibson, Public Works Department, states residents cannot have a driveway, only a few circumstances, if they are a tenant and the landlord does not let them park in the driveway, most are all legitimate, few have shared driveways, very hard to get through. She has looked into 833 Merrill, no sign there it is at 835. Jefferson (7218) not the person's driveway. All are inspected before they put up the signs. Jefferson (7120) was taken out. Mr. Margraf explains 5843 Columbia has a driveway, her difficulty is being able to back out. Mr. Margraf doesn't think that is a special circumstance. Ms. Gibson opinion is that if we open up one, then it will open up to the whole city and we'll be back and forth with these meetings. Mr. Long feels the same about the set of rules, now has a better understanding. Ms. Gibson states residents have to go through all the process and channels, and they are renewed

every two years. If she gets a call in about a sign, she checks it out first. Councilman Tyler questions the 1100 block of Eaton has a drive way as well as a sign, hard to back out of drive way this is the same issue, its more of a safety issue. Ms. Gibson states Eaton handicap sign is because the vehicle it too large/wide to fit in the driveway. Mr. Long states its impossible to know all but can someone have access as to what is special circumstances. Ms. Hill states this could be a good thing or a bad thing. Ms. Gibson states they don't have many cases they have a problem with and thinks we should leave it as it is for right now. Councilman questions if this process/decision making will go to the Board. Mr. Long states yes. Mr. Dean states he looked at the width of the driveway and it is 7 feet wide and driveway is right up against the house and sympathizes with woman trying to get into her vehicle in a wheel chair. He is referring to 5843 Columbia. Recommendation by Mr. Long to deny the handicap sign at 5843 Columbia; concurred by Mr. Margraf.

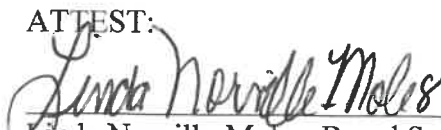
