

BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF JUNE 8, 2023

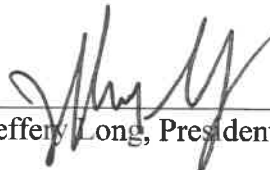

Under meeting open to Public, Mr. Button states the lane restricted on Hohman Avenue is scheduled for June 9.

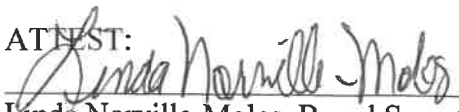
