7609 Alexander Owner appears. No action.

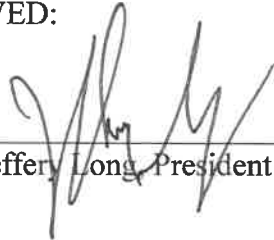
