Mr. Kearney is informing the Board that he may take emergency action under the code, this is not a hearing, just informing the Board. No action needed. Owner states they have multiple plans but the roadblock is lack of parking for this building. They are actively looking for a developer for an office building. They only had plans to develop it as an apartment building with commercial but cannot do it now. Mr. Kearney states the immediate concerns are the panels flying of the building with the high winds last week. Photos provided. Owner is aware and cleaned up the grounds. Mr. Long states Mr. Kearney has a duty to act under the I.C. code and making this very clear the city is moving forward with the emergency. Mr. Smith states this property is currently under an active demolition order, we are in the process of bidding out the demolition of the property. There is an environmental report that is extremely concerning, they can get a copy from Ms. Taylor in Redevelopment. Owner's experts say they can cure it. They have covered the roof to not have more water damage, the panels are a safety issue and he is addressing so no one will get hurt. Mr. Kearney states it was complicated to get a phone number or email address to make contact but have been sending demo orders to the address available. Mr. Bolchis disagrees, he has been in the city approximately 50 times. Ms. Taylor has his phone number, email address and multiple emails with the city. Mr. Smith suggests this be reset for next week for a status. No action. Motion by Ms. Greenwell to set for status on June 5, 2025; seconded by Mr. Kalina. AYES ALL. Motion carried. (Ins. No. 25-276)
