

BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF JUNE 12, 2025

Her husband previously took care of this matter. She provided photos of incidents with the house, meters and guardrails. Mr. Button states they will take a look into the background of this and help come up with a solution. Mr. Smith presents photos and states concerns of the neighbors, back shed is in terrible condition and an ongoing problem not necessary Mr. Abdullah’s fault but her purchased a certificate and the Deed probably won’t be issued until early 2026 so concerns from now until then on a remedy on this property and the city’s position is to affirm the demolition. Mr. Abdullah states he didn’t look at the property until after and would like to try to rehab it. In the meantime, he can cut the grass, take out the shed, maintain the outside. Mr. Long states there have been many complaints by the neighbors. Mr. Smith requests to affirm the order. Motion by Ms. Greenwell to affirm the order and set for status on July 10, 2025; seconded by Mr. Kalina. AYES ALL. Motion carried. (Ins. No. 25-340)

Status – 5217 Hohman – Owner Mike states they have secured the panels and have a canopy for protection. Mr. Smith states there is a current demolition order but wants to confirm they did get notice on the current owner. Owner would like to move forward and will provide some plans. Mr. Smith’s concerns are the environmental report and whether the water is impairing the building structurally and would encourage he talk with HDEM on his opinions and concerns. Mr. Kearney should advise the Board if work is being done by next week. Motion by Ms. Greenwell to set for status on July 10, 2025; seconded by Mr. Kalina. AYES ALL. Motion carried.
