Ms. Wilkerson, 6931 Jackson appears and doesn't want the street closure for the 4th of July, no one was notified until Friday and has signatures of other residence who do not want this. She has plans, neighbors have plans and had no idea this was going on until Friday. Mr. Long states a list that people don't want and signatures that do want it, there are a couple address that are the same. Ms. Cameron stated she reach out to city and followed the instructions she was given. Did not tell her she needed signatures beforehand. Was notified to let her know it would probably be appealed today and to obtain signatures. Wanted street closed for extra safety, more kids on block, friends over with little ones. This was not to be rude or upset neighbors that she didn't get signatures beforehand. Mr. Long asks is there is a compromise here and signatures are not required but preferred. We are just trying to find a way that is safe for you and also convenient for people to need to get to their house. Mr. Smith would like to accommodate everyone's desire to have a good time on the 4th, have fun, not have issues. It's tough because you both live across the street from each other. July 4th is a challenge around the city, several streets are blocked off but the majority are not blocked off. Not sure what the middle ground here is. Mr. Long states that it doesn't sound like it and that some addresses are the same on both. There are more signatures against than there are for with 2 or 3 addresses that are the same. Mr. Long states there doesn't look like there is a compromise today and signatures on both so doesn't feel they can grant the permission for it. Motion by Ms. Greenwell to amend the prior approval to close the 6900 block of Jackson and deny the request based on the information presented today; seconded by Mr. Kalina. AYES ALL. Motion carried. (Ins. No. 25-372)

Ms. Sanchez, 3828 Torrence questions if she can leave the area open, or do they have to fence it? Mr. Smith advises she would need to get a permit downstairs for a fence and you would need to check with Mr. Castro about keeping concrete pad for parking or some other use.
