**BOARD OF PUBLIC WORKS AND SAFETY
MINUTES OF JULY 3, 2025**

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:01 a.m. on Thursday, July 3, 2025, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Long – present; Ms. Greenwell – present; Mr. Kalina – present.

Motion by Ms. Greenwell to approve the Minutes of the meeting of June 26, 2025; seconded by Mr. Kalina. AYES ALL. Motion carried.

Under Correspondence, correspondence received from William Short, Chief of Police requesting Michael Gallardo be appointed as a probationary member and to serve his one year probationary period effective June 26, 2025; Officer Ariel Alvarez-Ortega to receive ET Specialty Pay effective June 27, 2025; Officer Brandon Kerwin is no longer performing the duties of Evidence Technician and will relinquish his ET Specialty pay effective June 27, 2025; and Correctional Officer Aleksander Jovanoski is now eligible to receive the promotional raise due to him effective July 1, 2025. 
