BOARD OF PUBLIC WORKS AND SAFETY MINUTES OF JULY 7, 2022

The regularly scheduled meeting of the Board of Public Works and Safety convened at 9:04 a.m. on Thursday, July 7, 2022, in the Council Chambers of Hammond City Hall. A roll call was taken: Mr. Margraf – present; Mr. Long – present; Mr. Perez – absent.

Due to the absence of Mr. Perez, normal rules of procedure are suspended.

Recommendation by Mr. Long to approve the Minutes of the meeting of June 30, 2022; concurred by Mr. Margraf.

Under Matters from Department Heads/Their Representatives, Mr. Button requests approval of "Cross Traffic Does Not Stop" signs at 174th at Alabama (2) and 174th at Arizona and to forward to Public Works for placement. Recommendation by Mr. Long to approve the request; concurred by Mr. Margraf. (Ins. No. 22-411)

Mr. Button advises that Whiteman Engineering, who is doing work for NIPSCO, has requested to work on Gostlin Street for their measure downs data on the sewer lines. Mr. Button gave them the approval and is advising the Board, not a lane restriction or closure but may stop traffic for a minute. Recommendation by Mr. Long to approve; concurred by Mr. Margraf.
