Capital Improvement Board - Councilwoman Venecz - Next meeting will be on February 1st due to the Martin Luther King holiday. Study session at 4 p.m. and the meeting will follow at 5 p.m. The Board approved the Chicago Street Phase 2 construction local match for \$905,115.60. That is a 20% match. Also approved was the Chicago Street Phase 2 construction engineering that was \$616,583.26. We also received a request form Councilman Emerson to consider the 75 and half of the 7600 blocks of VanBuren. The total cost of that project is to be determined.

Covid Task Force Committee - Councilwoman Alexander - The Covid numbers for our city; 46320 has an additional 34 cases; 46327 has an additional 31 cases; 46323 has an additional 65 cases; 46324 has an additional 68 cases; 46394 has an additional 29 cases.
