### MAYOR'S ADDRESS

Mayor McDermott- Hi, nice to see everybody. This is my report for April 28, 2025. I'm available for questions if anybody has any. Not as much as usual for this period. We did have a holiday right in the middle of it. I did meet with the developer that currently owns the old Walmart in Hammond's 3<sup>rd</sup> District. He currently owns it. It's a Porter County Councilman, owns it, and it about to flip it to a gentleman from Hammond. They have plans. They're talking to a business from Porter County, relocating there. They're also talking to a couple of the current tenants on the footprint where we need to clear out the footprint so that we can expand the water park. That's all being planned for the old Walmart right now. That is in the process of being flipped to a new developer and we're in communication with them. It seems like everything is heading in the right direction over there. I appeared on WJOB Morning Show with Tom Dabertin to speak about the effects of Hammond's budget from the proposed new convention center located in the Hard Rock Casino. So far we are down \$13 million in our budget, most of that lost to Hard Rock. Anyway, I've done a lot. After the last Council Meeting, I've appeared on quite a number of different places talking about the effects that this convention center will have on our city. I attended the ground breaking for PNW's third dormitory. This one is going to be located on campus north of 173<sup>rd</sup> street, right off of Woodmar and 173<sup>rd</sup>. This is the first dorm on campus. It's across the street from where the other dorms are, but it's technically considered on campus. It's a big move for Purdue, It's a big project. I think it was a \$30 million project. They're breaking ground on it, it's underway right now, so that's good news. I met with the CEO of the South Shore Convention and Visitors Bureau, Phil Taillon, to speak about the effects of locating Hammond's, upon Hammond's budget from proposed new convention center locating next to Hard Rock Casino. I know that the CEO of the South Shore Convention and Visitors Bureau badly wants a convention center built. I think he doesn't really care as much about where it's built as long as it's built. He's got an interesting perspective. I still personally don't feel that we need one, but I know where they sit. They think we need one. They're not necessarily sold on Hard Rock. They think if it happens in Hobart, they're happy. That's what I've heard so far. I attended the grand opening of The Branding Room Floor, a new marketing agency. They opened up in Downtown Hessville. It was a great event. Jaime Prieto's wife Cynthia is one of the Co-owners of The Branding Room Floor. That was a nice event we held in Hessville. I met with US Senator Jim Bank's, District Director, LeAnn Angerman. I've known LeAnn for a long time. She was on the Lake County Election Board served in the Elections and Registrations Office for a number of years, so I knew

Mayor McDermott cont.- her through that process. It was nice to speak to her. She came in and talked about what was going on with Senator Banks. He had some questions about some projects in the city that I cleared up. This is interesting, I want to thank Dean Button for meeting with me to discuss the status of quiet zone applications. I know this is important with Councilman Salinas. We're actively working to make the IHB crossing, at Sohl Avenue near Willow Court a quiet zone crossing. We are actively exploring 5 quiet zone applications for the Norfolk Southern line from Willow Court to Sohl Avenue. They have some complaint that have come from complaints we received from tenants at the bank and at Renaissance. We recognize the current conditions may have detrimental impact on attracting residential housing in Downtown Hammond. Obviously I've been talking to the seniors that live at the Renaissance for a number of years. This is a process that we're going through right now. I want to thank Dean for starting that process. I met with the new School City of Hammond Superintendent Talisa Reed. We had a nice meeting over at Byway Brewery, you know, talking about cooperative issues that could take place between the school city and the civil city, so it was nice speaking to her. I think she's a great Superintendent. Quite frankly, I think they made an excellent decision. It seems like we're going to have a great relationship. If you haven't had a chance to talk to the new Superintendent, I recommend doing so. She's a breath of fresh air. I had lunch with the CEO of the Horshoe Casino Hammond last week. Obviously there's a lot going on in the casino industry. I've been talking real close to the leadership of Horshoe Casino constantly. They know what's going on with us. They know what's going on with the convention center and they're monitoring obviously. It impacts them greatly. We hosted bring your child to work day in Hammond City Hall. It turned out to be a great event. I want to thank everyone that participated. Last but not least, I attended the coldest opening day I've had in a long time. It was in Robertsdale. It was literally in the 20's. Councilman Spitale, and Councilwoman Venecz were there. It was a cold one. Robertsdale Little League is playing though. It was 20 degrees, but they still played. I know that you all have Ordinance 25-10 coming before you. It's an ordinance to appropriate funds in the hotel/motel innkeeper's tax fund for Economic Development purposes in 2025. I know that's going to have a public hearing next meeting. If you have any questions, I'm here to answer them, other than that, that's my report.

Councilman Kalwinski- Evening, Mayor.

Mayor McDermott- Yes, sir. Hi Councilman.

Councilman Kalwinski- Last time we had a council meeting, you were going to meet with NIPSCO and I mentioned;

Mayor McDermott- Yes, 2 things with NIPSCO.

Councilman Kalwinski- the gas and electricity.

Mayor McDermott- Yes, sir.

Councilman Kalwinski- What do you know?

Mayor McDermott- We followed that up. I haven't had a chance to meet with NIPSCO yet, not for lack of trying. I'm trying to meet with the CEO on a couple of things. That's one of them. I did get some follow up on this issue. I'm aware that within the next 4 weeks, NIPSCO plans to have full power to that area. I don't know

Mayor McDermott cont.-much about building houses, so I talked to people that know a lot about building houses. In fact, I'm surrounded by them right now, in case you have any further questions from what I understand, having temporary power in a situation like this is not completely unusual. NIPSCO is aware that we need power out there. We did drop the ball, I acknowledge. My administration did. I didn't personally, but I'm the boss, so I take responsibility, but they will have power out there within the next 3-4 weeks.

Councilman Kalwinski- Thanks.

Mayor McDermott- We did follow that up, Councilman. I didn't have a chance to talk to the CEO yet. I wanted to talk to him about not only yours, but about data centers. That's the big thing right now.

Councilman Kalwinski- Was there any discussion about or talk about moving NIPSCO from the easement to the front?

Mayor McDermott- That is a NIPSCO decision. That was part of the reason we don't have power right now. That's part of the reason. When you think about all the new developments NIPSCO has, they don't come from the back with power anymore, they go through the front. We were prepared, because almost every development we have, the power comes through the front, and we had to make that, excuse me, the power comes from the back, we had to make that change. That's part of the reason.

Councilman Kalwinski- I guess the question people will ask then, is will there be a public sidewalk in front?

Mayor McDermott- There is going to be a public sidewalk in front. We had to rearrange that too, right?

City Engineer, Dean Button- There is a public sidewalk in front. We're working on exact location.

Mayor McDermott- But we had to change that around with the;

City Engineer, Dean Button-Little bit of change, but, there will be a sidewalk in front.

Mayor McDermott- There will be a sidewalk in front, Councilman.

Councilman Kalwinski- Will it be along the curb or will it be a little parkway?

City Engineer, Dean Button- We're hoping to have parkway. It sort of depends on where NIPSCO puts their facilities in, but we're working towards having a parkway.

Councilman Kalwinski- I think a parkway not going to be for a little bit. Thanks for trying.

Mayor McDermott- I appreciate you bringing it up last meeting. I got heavy on that subject, so I was ready for your answer, but I did not get a chance to talk to the CEO yet. I wanted to talk to him more about data centers and that also concerns your district. We have a big proposal on the table right now, and NIPSCO holds the keys, literally. If NIPSCO says yes, you guys are going to be happy with us.

MAYOR'S ADDRESS cont.

Councilman Kalwinski- Data center?

Mayor McDermott- Yes, a big one. Big one. It's a good proposal for our city. It's adjacent to a current data center. We don't have neighbor problems at that data center. We have power problems. That's what we're trying to work out with NIPSCO. It's literally, everything is done. We've done everything you could do. We're literally waiting on NIPSCO.

Councilman Kalwinski- As you probably know, people are concerned that they're going to be paying for the power that goes to the data center.

Mayor McDermott-Well, that's a really good point you bring up. That's part of the problem right now, is NIPSCO has a proposal where they're pulling data centers out of NIPSCO utility and what that does for us utility payers, it's not a good deal for us. This data center is going to pull more power than US Steel. The data center we're talking about is going to pull more power than US Steel, which is a great customer for NIPSCO. NIPSCO should leave, in my opinion, not that it matters, but I think that it belongs in the rate with all of us, so it can help pay for our lower rates here in Northwest Indiana. If they're siphoned off, data centers are being talking about siphoned off out of NIPSCO and put into a separate company basically that only deals with data centers, that reports basically to a hedge fund. That's no good.

Councilman Kalwinski- How do they prioritize?

Mayor McDermott- That's a great question, Councilman. We have a proposal ready to go right now. Hammond does. We're ready to go right now. We don't have cooling problems. We don't have neighbor problems. We have a data center there already. We need mega watts. That's what's holding us up, and NIPSCO has all the keys. If NIPSCO says yes, I'm coming back here and buying pizza, and we're gonna have a party. If NIPSCO says no, I don't know what the answer is, being honest. There's not enough power in NIPSCO's service territory for all these data centers that are knocking on our door. Indiana made us very attractive to data centers with our legislation and the laws that we have in Indiana and then the data centers come here, and they say do you have the power, and we say no. We have all these great laws on the books, but we don't have the power, sorry. They're like, why are you even talking to us if you can't even get us the power. That's the most important part.

Councilman Kalwinski- Thanks

Mayor McDermott- Thank you, but when I do talk to him, I will report, I promise you. Any other questions? Thanks everybody.

Councilwoman Venecz- Thank you, Mayor.
