MAYOR'S ADDRESS

Mayor McDermott- Hi, how's it going? Thanks, Councilman Woerpel. It's good to see the Council. I'm giving you my report for May 12, 2025. I met with Councilwoman Venecz, and Councilman Spitale on the possibility of Hammond becoming AARP friendly city. They've done a lot of research on this. I think you guys will be hearing more about this in the future. National Day of Prayer was held over the last couple of weeks as well at the Dynasty Banquet Hall. I want to thank the Council Members for attending that as you always do, and for being in attendance. It was a really nice day. Ribbon cutting for Firehouse #2 occurred over the last 2 weeks also. Firehouse #2 is in Hammond's Robertsdale section. Councilman Kalwinski hosted that day. We had to have 300-400 people there that day. It was really nice. That new Firehouse is up and running. It was up and running before we cut the ribbon, but it was a really good day to see that happen in our city. I met with the CEO of NIPSCO in regards to data centers, Vince Parisi. Vince is a great guy, a normal guy. I know he's trying to do the right thing for Northwest Indiana. He is an important person for us as far as we need megawatts, and it's going to be up to NIPSCO on who gets those valuable megawatts. If we get them in Hammond, we could do a big deal, bigger than we've ever done before. NIPSCO's got a lot of proposals that they're considering right now. Ours is on there along with them. I think any chance we get to talk to the CEO of NIPSCO is a good opportunity for all of us. Hammond Police monthly Captain's meeting occurred. I met with the Captain's and Chiefs from the Hammond PD regarding crime stats, transit, personnel issues. Councilwoman Venecz and I also touched base regarding a variety of topics as we usually do. I met with the Sanitary District Officials over a proposed digital billboard Lamar wants to put up on Hammond Sanitary District Property. If that moves forward, it'll have to come before the Hammond City Council. We'll be talking to you about that if we're going to move forward. Last but not least, met with Councilman Scott Rakos, for lunch at Freddy's Steakhouse. It was a really good day. Resolutions by the Council, today you have a resolution before you sponsored by Councilman Dave Woerpel, 25R-10. I heard you all talking about it in regards of making a good faith offer for the purchase of Cooper Tire, it's like 7300, I don't know the exact address on Indianapolis Blvd. Another resolution also. coming before you in regards to the Economic Revitalization area. Port Authority bonds, I know we're talking about that introduction of ordinance, if you have any questions about that, I have details on me as well. 3 141st, I know Councilman Kalwinski pays close attention to that. The warehouse building on that property is having it's old exterior panels removed and the new exterior panels are already on the property ready for installation. It's

INTRODUCTION OF ORDINANCES

An Ordinance of the Common Council of the City of Hammond, Indiana, Approving and Authorizing the Issuance and Sale of Revenue Bonds of the City of Hammond, Indiana, to Procure Funds to Finance Certain Projects Recommended by the Hammond Port Authority, Together with Expense in Connection With the Issuance of the Bonds

Councilwoman Venecz, supported by Councilman Emerson, moved the proposed ordinance to 1st and 2nd reading by title, referred it to the Council as a Whole Committee for May 27, 2025 at 5:15 p.m.

Councilwoman Venecz- This is a request for a \$25 million dollar bond, for renovation and construction of docks at the Marina and also to continue the repairs to the break wall at the Marina.

Councilman Kalwinski- Just a quick question, if we spend the whole \$25 million, what is the total payback of the loan, of the bond, what will it be?

Councilwoman Venecz- What was the question?

Councilman Kalwinski- How much with the interest are we paying back on the bond over the \$25 million. I wonder if we have a number yet?

Councilwoman Venecz-I don't have a number for that, Councilman. I can tell you that the bond will be paid by slip fees and income at the Marina, that I can tell you. I cannot give you an answer on that at this time.

Mayor McDermott- Councilman Mark, we'll get you the exact number, next meeting. It's 1st and 2nd reading. This, just for everybody's information, the current bond that originally paid for the bridge over Calumet Avenue, at Wolf Lake Memorial Park, the hill for viewing at the Pavilion, the water pipe relocation, and the trails in and around Wolf Lake and Lost Marsh, is falling off. This new bond is going to be issued to help pay for the breakwall, the 2nd phase of the breakwall. We already did the 1st phase of the breakwall project. The 2nd phase which replaces the original rocks with much larger rocks, so that we don't destroy everything we're building right now. We all remember that 1 Halloween night in Whiting, and they had too small of rocks and their park got annihilated by waves. We have to invest in our break wall to make sure that doesn't happen to our marina. That's one of the projects that's moving forward. We're also going to do projects replacing docks with it, and that's very expensive. Each dock that we replace is almost a million dollars each. 25 million between the breakwall, the docks, and we also plan to replace the aging fuel tanks, a couple other just knick knacks around the Port Authority, but, obviously a 25 million dollar bond paid off over a period of years is going to result in probably, I imagine, twice, I don't know, in that ball park, but we'll get you that exact number next meeting.

Councilman Kalwinski-Thanks

Councilwoman Alexander- Also Mayor, it's my understanding that we have to replace those docks because they are over the amount of time, meaning, I think they were extended for like 20 years, and they're at 30-34 years now?

Mayor McDermott- Exactly, Councilwoman. Original docks were designed for a 20 year life, and we're at 34 years old at this point. You know, we do our best to maintain them, but they get splintery, and they get old. We are replacing the docks one at a time. It's about a million dollars a hit. This is a 25 million dollar bond with a lot of work going into the breakwall, so they'll be doing docks one at a time. I'm trying to think, which dock are you planning on doing with this, Jeff?

Jeff Smith- B & T

Mayor McDermott- B & D?

Councilman Kalwinski-B, T, and H when you're doing the breakwall.

Jeff Smith- Well, with the breakwall, H dock will have to be done, but B & T right now.

Mayor McDermott- Ok. That's thumb rule, 2 ½-3 million dollars right there on docks. This is 1st and 2nd reading, so if we don't have the information you guys need, obviously we'll have it by the next meeting.

Council President Woerpel- Thank you. Any further questions? Councilwoman, I wasn't being, I was just looking to see if you had a question, and I just went like that, I wasn't being disrespectful.
