Chairman /President Scott Miller - So that concludes all of the organizations that did receive money. I am going to now entertain a single motion for the organizations that unfortunately we were not able to provide funding to this year. Before I do that, I'm just going to side for a second for anyone watching this, that just a few years back this committee had over \$2.5 Million dollars to help fund many different groups, and this year the grand total was \$427,100 that we were able to bless organizations with. So, we have roughly twenty percent of the funding that we had a few years ago. So, we did have to prioritize organizations that in some cases they don't have significant other income streams. Some of the organizations you're going to hear their name, you might say why isn't the city supporting them? Cause we know they're not going to hurt badly if we don't support them. There's other organizations on here, however, we didn't want to be their only income stream where the entire organization only exists based off Hammond gaming dollars. We also looked that some of the organizations that applied, they maybe, they don't reside in Hammond or their entire board doesn't reside in Hammond and only a portion of their operation benefits Hammond residents. We also looked at organizations that are brand new to the city and we want to be responsible with our dollars and make sure that they stick around in the city before we're funding their organization. We also even had some for-profit organizations apply this year. This program is not meant to supply the needs of for-profit organizations it's meant for non-profits in our community that our serving our Hammond residents so that said I'm going to entertain a motion that following organizations will not be receiving funding for the 2025 year. These organizations are: The Boys & Girls Club of Greater NWI, Freedome Center Indiana Inc, Genius Guild, Goodwill LEADS, Inc. Hammond Excel Center High School, Hammond family YMCA, Hope Angels Fund, Jewels - The Women's Ministry That Sparkles For Jesus, Living Water Missionary Baptist Church, Love Set Free Inc, Meals On Wheels of NWI, Northgate Church, Purdue University Northwest College of Engineering & Technology, Silverstray Social, Sk8 America Fitness & Educational Development Corporation, South Shore Toy Project, TCA Health Inc. The GO Church Chicago, The Welcome Network, Trios Little Tots, True World Evangelistic Outreach Ministries, TURNT Youth Organization, United Way, Forest Heights Community Garden.
