ENTRY INTERVIEW:

Upon entry, I met with Dan Shirley, Environmental Manager for Indiana Harbor Belt Railroad. I informed him that this is an Annual Inspection, and that I wanted to inspect the locally permitted items listed in the operation permit.

INSPECTION OBSERVATION(s):

- 1. Process Equipment: Diesel Storage Tanks T1 and T2: Tank T1 Tank T2
- 2. <u>Process Description</u>: Two (2) Volatile Organic Liquid Storage Tanks, identified as T1 and T2, with a maximum capacity of 48,954 gallons each, (Diameter 13', Height 50'), servicing #2 Fuel Oil.
- 3. <u>Pollutants Emitted:</u> Volatile organic compounds (VOC)
- 4. <u>Control Equipment</u>: No control equipment.
- 5. <u>Applicable Rules</u>: 326 IAC 8-9 (Volatile Organic Liquid Storage Vessels), 326 IAC Article 2 (Permit Review Rules), and Hammond Ordinances #7102 (Hammond Environmental) and #3522 (as Amended) (Hammond Air Pollution Control)
