AN ORDINANCE ESTABLISHING A NON REVERTING FUND FOR THE COLLECTION OF FEES ASSOCIATED WITH ORDINANCE 7676 - STANDARDS FOR INDUSTRIAL FURNACES OR BOILERS THAT BURN HAZARDOUS WASTE
