AN ORDINANCE CREATING A NEW FUND (FUND #150) FOR U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES CARES ACT PROVIDER RELIEF FUNDS FOR THE CITY OF HAMMOND AMBULANCE SERVICES DURING COVID-19

WHEREAS, through the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the federal government has allocated funds to be distributed through the U.S. Department of Health and Human Services (HHS) Provider Relief Fund; and

WHEREAS, the HHS Provider Relief Fund grants payments to qualified providers of health care services and support for healthcare-related expenses due to COVID-19; and

WHEREAS, the City of Hammond is a recipient of HHS Provider Relief Funds for its ambulance services during the COVID-19 pandemic and requires a dedicated fund to receipt and disburse this grant money; and

WHEREAS, the City of Hammond must now have a new fund established for receipt and distribution of these funds; and

WHEREAS, Megan Flores, City Controller, requests that a new account, number 150, be dedicated and created for the City of Hammond for purposes of accessing funds for the HHS CARES Act Provider Relief Funds with the Revenue Account being 150-33119 and the Budget Account being 150-439.00-900; and

WHEREAS, the creation of this fund is not an additional appropriation and a public hearing is not required;
